RESOLUTION RESPECTFULLY REQUESTING HONORABLE GRINGO HONOSAN , SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE TWO MILLION PESOS (P2,000,000.00) FOR THE MAINTENANCE AND GRAVELLING OF DAPDAP-LUBOG ROAD, IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Barangay Dapdap is 9 kilometers from the Poblacion and Barangay Lubog is 11 kilometers:

WHEREAS, Barangay Dapdap and Lubog is almost 2.5 kms. from the provincial road with rough roads;

WHEREAS, Barangay Dapdap is almost 2.5 kms. from the provincial road with rough roads;

WHEREAS, Barangyas Dapdap and Lubog have wide farmlands suited to agriculture;

WHEREAS, the residents in these two barangays are mostly farmers who depend solely on farming as their means of livelihood;

WHEREAS, in case of emergency, the residents of these barangays find it difficult to bring their patients to the hospital;

WHEREAS, the putting up of farm to market roads will make easier especially to the residents through increased revenues that will be generated from taxes on farm products;

WHEREAS, if these roads will be improved it will be easier for the people to transport their products to the poblacion thus improving their means of livelihood;

WHEREAS, to populace will be thankful to the good Senator for the realization of their dreams of having good roads linking their place to the provincial and national roads;

NOW, THEREFORE, on motion of Hon. Fernando Valencia, Chairman, Committee on Infrastructure and General Services and duly seconded by Hon. Romeo Ledesma and Hon. Cecilia Garrido,

RESOLVED, to respectfully request Hon. Gringo Honasan, Senator, Republic of the Philippines to allocate Two Million Pesos (P2,000,000.00) for the maintenance and gravelling of Dapdap-Lubog Road, in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Gringo Honasan, Senator, republic of the Philippines for his information and appropriate action.
