RESOLUTION RESPECTFULLY REQUESTING HONORABLE PANFILO LACSON, SENATOR, REPUBLIC OF THE PHILIPPINES, TO ALLOCATE TWO MILLION PESOS (P2,000,000.00) FOR THE MAINTENANCE AND GRAVELLING OF TARO-ALUPIDIAN ROAD, IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Barangay Taro-Alupidian Road, a farm to market road, stretches about 3 kilometers and connects the Barangay of Taro and Alupidian, Municipality of Tigbauan, Iloilo;

WHEREAS, the said road is considered as the route of agricultural products and other industries produced by the farmers situated in the area and marketed in the Municipalities of Tigbauan, Leon, Alimodian, San Miguel, the city of Iloilo and other adjacent municipalities in the province;

WHEREAS, some portions of the road had become impassable and were closed for transportation making it difficult for the farmers to transport and sell their products in the market;

WHEREAS, due to financial constraints, the municipality has no available funds for the repair and maintenance of said road;

WHEREAS, because of the prevailing unfavorable road condition and high cost of transportation, the government suffers much of losses, hence, the delivery of the basic government services to the said community is greatly hampered/affected;

WHEREAS, the rehabilitation of the said road will enhance the delivery of the farm products and other industries of the farmers in the said community;

NOW, THEREFORE, upon motion of Hon. Fernando Valencia, Chairman, Committee on Infrastructure and general Services and duly seconded by Hon. Romeo Ledesma, Hon. Cecilia Garrido and Hon. Agaton Tumabotabo,

RESOLVED, to respectfully request hon. Panfilo Lacson, Senator, Republic of the Philippines to allocate Two Million Pesos (P2,000,000.00) for the maintenance and gravelling of Taro-Alupidian road, in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Panfilo Lacson, Senator, Republic of the Philippines for his information and appropriate action.
