RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE VICE GOVERNOR ROBERTO ARMADA, PROVINCE OF ILOILO, PROVINCIAL CAPITOL, ILOILO CITY, IN THE AMOUNT OF TWO HUNDRED FIFTY PESOS (P250,000.00) FOR THE CONSTRUCTION AND IMPROVEMENT OF THE DRAINAGE SYSTEM IN THE POBLACION AREA OF THE MUNICIPALITY OF TIGBAUAN

WHEREAS, the drainage system in the Poblacion area of this municipality was constructed in the year 1950's and some minor improvements had been done only in the year 1960's, 1970's and 1980's;

WHEREAS, considering that the said drainage system had been designed more than five decades ago and without major improvements being undertaken despite the tremendous increase in population, it was noted that it is no longer capable of accommodating the heavy volume of water during the rainy season, thus flooding the roads, residential houses and the low-lying areas of the poblacion;

WHEREAS, the overflowing of water from the street canals of the Poblacion during heavy rains cause inconvenience to the public and may jeopardize their health;

WHEREAS, unless the drainage shall be reconstructed/redesigned, the problem on flood waters during rainy season will remain unsolved;

NOW, THEREFORE, on motion of Hon. Fernando M. Valencia, Chairman, SB Committee on Infrastructure and General Services and duly seconded unanimously,

RESOLVED, to request financial assistance from Honorable Vice Governor Roberto “Obet” Aramada, Province of Iloilo, Provincial Capitol, Iloilo City, in the amount of Two Hundred Fifty Thousand Pesos (p250,000.00) for the construction and improvement of the drainage system in the poblacion area of the Municipality of Tigbauan, province of Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to the Hon. Mayor Myrna M. Torres, and Hon. Vice Governor Roberto “Obet” Aramada, Province of Iloilo, Provincial Capitol, Iloilo City, for their information, guidance and/or appropriate action.
