Resolution No. 2001-094

RESOLUTION STRONGLY URGING PNP SR. INSPECTOR ANTONIO B. BERSAMIN, CHIEF OF POLICE, AND THE ENTIRE TIGBAUAN PNP COMMAND, TO EXERT EXTRA EFFORTS IN ARRESTING OR APPREHENDING ANY OR ALL ALLEGED PUSHERS/TRAFFICKERS OF DANGEROUS DRUGS ALLEGEDLY OPERATING IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, school officials, Ngo's, teachers and parents are urgently concerned regarding the alleged proliferation of dangerous drugs in Tigbauan;

WHEREAS, now is the time for concerned authorities to act, because heinous and petty crimes reported every day by print and broadcast media are almost always drug related;

WHEREAS, the creeping menace of drug addiction is the worst problem we are facing now, because it saps the strength of our students and the youth, and it destroys their future;

WHEREAS, there is truth to the axiom that where there are no pushers or traffickers, there will be no users, or at least users will be reduced to nil;

WHEREAS, traffickers or pushers of prohibited drugs violate specifically Section 15 of Republic Act 6425, as amended, otherwise known as the Dangerous Drugs Act;

WHEREAS, Her Excellency, President Gloria Macapagal-Arroyo has vowed to “ ... wage a total all out war against drug trafficking”;

WHEREAS, the Senate Committee jointly conducting the current investigation/hearings on drug involvement have issued this statement: "... Law enforcement agencies must exert more efforts to ferret out those involved in the illegal drug trade";

NOW, THEREFORE, upon motion of Hon. Romeo T. Ledesma, Chairman, Committee on Good Government, Public Ethics, Accountability and Civil Services and duly seconded by Hon. Agaton Tumabotabo, Hon. Cecilia Garrido, Hon. George Tribunal, Hon. Rexfel Trivilegio and Hon. Alfonsito Estoce Be It,

RESOLVED, to strongly urge PNP Sr. Inspector Antonio B. Bersamin, Chief of Police, and the entire Tigbauan PNP Command, to exert extra efforts in arresting or apprehending any or all alleged Pushers/Traffickers of dangerous drugs allegedly operating in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward this Resolution to Sr. Inspector B. Bersamin and the Tigbauan PNP Command, for appropriate action,

RESOLVED FINALLY, to provide copies of this resolution to authorities concerned, DECS Officials, NGOs, and PTAs, for their information and proper action thereon.
