RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, MYRNA M. TORRES OF TIGBAUAN, ILOILO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) REIONAL OFFICE, THE BUREAU OF LOCAL GOVERNMENT DEVELOPMENT (BLGD) AND THE MUNICIPALITY OF TIGBAUAN FOR THE INSTAALLATION AND IMPLEMENTATION OF THE FOLLOWING COMPUTER BASED ADMINISTRATIVE SYSTEMS: MANAGEMENT INFORMATION SYSTEM (MIS), PERSONNEL MANAGEMENT INFORMATION SYSTEM (PMIS), REAL PROPERTY TA – BILLING AND COLLECTION SYSTEM (RPT-BCS), BUSINESS PERMIT AND LICENSE SYSTEM (BPIS) AND SANGGUNIANG INFORMATION SYSTEM (SIS)

WHEREAS, the local government units are mandated to uplift the lives of its constituents and as a whole to be progressive and competitive community;

WHEREAS, the Bureau of Local Government and Development (BLGD) is mandated to assist and strengthen the capabilities of local government units particularly their administrative, technical and fiscal capabilities to enable them effectively deliver basic services to its constituents;

WHEREAS, information technology, through the computer based administrative system, is one tool of improving the administrative capacities of LGUs for effective governance;

WHEREAS, the DILG, through the Bureau of local Government Development, has developed the following computer based administrative systems: Management Information System (MIS), Personnel Management Information System (PMIS), Real Property Tax- Billing and Collection System (RPT-BCS), Business Permit and License System (BPLS) and Sangguniang Information System (SIS);

WHEREAS, the Municipality of Tigbauan is desirous to adopt the said application systems and its accompanying policies;

WHEREAS, DILG, Region VI fully supports the implementation/installation of these application system in LGUs within their respective jurisdiction;

NOW, THEREFORE, on motion of Hon. George T. Tribunal, Chairman, Committee on Trade and Industry and duly seconded by Hon. Alfonsito Escote & Hon. Rexfel Trivilegio.

RESOLVED, to authorize the Municipal Mayor, Myrna M. Torres of Tigbauan, Iloilo to enter into a Memorandum of Agreement with the Department of interior and Local Government (DILG) Regional Office, the Bureau of Local Government Development (BLGD) and the Municipality of Tigbauan for the installation and implementation of the following Computer Based Administrative Systems: management Information System (MIS), Personnel Management Information System (PMIS), Real Property Tax-Billing and Collection System (RPT-BCS), Business Permit and License System (BPLS) and Sangguniang Information System (SIS),

RESOLVED FURTHER, to forward copies of this resolution to the DILG Regional Office, Iloilo City, to them Bureau of Local Government Development (BLGD), Francisco Gold Condominium III, Quezon City, to the Municipal Mayor, to the Department Heads, to the MLGOO, Tigbauan, Iloilo for their information, guidance and/or appropriate action.
