RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, FIRST ENGINEERING DISTRICT, PROVINCE OF ILOILO TO TRANSFER TO THE LOCAL GOVERNMENT UNIT OF THE MUNICIPALITY OF TIGBAUAN, ILOILO THE FUNDS INTENDED FOR THE MAINTENANCE OF FARM TO MARKET ROADS FOR ADMINISTRATIVE IMPLEMENTATION OF THE PROGRAM

WHEREAS, the Municipality of Tigbauan, Iloilo has acquired One (1) Unit Loader, One (1) Unit Road Grader and a Dump Truck intended for the maintenance and construction of farm to market roads in the Municipality of Tigbauan;
