RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM EXECUTIVE SECRETARY ALBERTO ROMULO, MALACANANG PALACE MANILA IN THE AMOUNT OF FIVE MILLION PESOS (P5M) FOR THE PURCHASE OF 1 UNIT ROAD ROLLER AND 2 UNITS DUMP TRUCK FOR THE USE OF THE MUNICIPAL GOVERNMENT OF TIGBAUAN; THE CONSTRUCTION OF ANNEX BUILDING OF THE MUNICIPAL HALL OF TIGBAUAN AND THE ELECTRIFICATION OF DIFFERENT BARANGAYS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, there are already 36 barangay road sections in the Municipality of Tigbauan, Province of Iloilo with an approximate length 44.987 kms;

WHEREAS, the Municipal government of Tigbauan can not maintain regularly these barangay roads due to financial constraints and lack of heavy equipment (to maintain said roads);

WHEREAS, it is necessary that the municipality shall have a road roller and a dump trucks for the exigency of service in the maintenance and compaction of said barangay roads;

WHEREAS, the Municipal Hall of the Municipality of Tigbauan was constructed in the year 1950's;

WHEREAS, the design of the construction was based on a small number of officials and employees only;

WHEREAS, this year 2001, the Municipal Government of Tigbauan has more or less 150 officials and employees rendering service to the people;

WHEREAS, there are so may barangays and sitios in the Municipality of Tigbauan yet in need of electrician program;

WHEREAS, for the reason of lack of funds, we can not energize our other barangays and sitio's because of the present policy of Ileco I, which is to provide 50% counterpart for the LGU and 50% counterpart on the part of Ileco I;

NOW, THEREFORE, upon motion of Hon. Alfonsito E. Estoce, Chairman, SB Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Romeo T. Ledesma,

RESOLVED, to request financial assistance from Executive Secretary Alberto Romulo, Malanang Palace Manila, in the amount Five Million Pesos (P5M) for the purchase of 1 unit Road Roller and 2 units Dump truck for the use of the Municipal Government of Tigbauan; the construction of Annex Building of the Municipal Hall of Tigbauan and the Electrification of different barangays of the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish a copy of this Resolution to Hon. Alberto Romulo, Executive Secretary for his information and favorable consideration.
