RESOLUTION INFORMING THE SANGGUNIANG PAMBARANGAY OF BARANGAY NAMOCON, TIGBAUAN, ILOILO THAT UNNUMBERED RESOLUTION OF SAID BARANGAY WAS ALREADY DELIBERATED AND ACTED UPON

Presenting for consideration is unnumbered resolution of Sangguniang Pambarangay of Barangay Namocon, requesting for the immediate construction of barangay road connecting the national highway to the coastal portion of said barangay, passing the right side of barangay chapel;

WHEREAS, the Chairperson, Committee on Barangay Affairs, rendered her committee report on October 2, 2001 S.B.'s regular session;

WHEREAS, in its recommendation she recommended for the settlement between the barangay officials and the heirs of the Lot No. 923-D-11;

WHEREAS, the barangay officials of Barangay Namocon shall coordinate with the Regional Director of the Department of Environment and Natural Resources to seek advice on how the said lot shall be acquired by the barangay:

WHEREAS, it is also recommended that a resolution be passed by the Sangguniang Barangay requesting financial assistance from Governor, Province of Iloilo to finance the proposed barangay road project;
