Resolution No. 2001-105

RESOLUTION REQUESTING HON. FRANKLIN M. DRILON, SENATOR OF THE REPUBLIC OF THE PHILIPPINES TO ALLOCATE TEN MILLION PESOS (P10,000,000.00) FOR THE CONSTRUCTION OF A MULTI PURPOSE CULTURAL CENTER, A MUNICIPAL HALL OF JUSTICE, AN INTEGRATED MARKET COMPLEX, INCLUDING THEIR RESPECTIVE AMENITIES AND/OR FACILITIES, IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Tigbauan is a fast growing municipality with 52 Barangays, having a total population of 51, 368 as of the latest census, and with 25,357 registered voters as of May 14, 2001;

WHEREAS, because of a rapidly expanding population and a presently congested marketplace, the Municipal Government of Tigbauan is planning to relocate its old market from the center of the town to somewhere just outside the Poblacion, but within easy reach of the inhabitants;

WHEREAS, a portion of the allocation/amount hereinabove requested, shall be used to purchase the new market site just outside the Poblacion;

WHEREAS, on the old market site, which is at the heart of the Poblacion, shall stand the Multi-Purpose Cultural Center, and the Municipal Hall of Justice;

WHEREAS, these edifices shall be so planned to complement each other, and shall be so constructed to integrate into an aesthetic landscape;

WHEREAS, the Department of Tourism Region VI had recommended Tigbauan as worthwhile visiting by virtue of its rich historical and cultural attractions;

WHEREAS, the Municipal Government of Tigbauan is in quandary where to hold our Cultural Presentation, such as when MONIQUE WILSON, famous stage and screen actress, performed in Tigbauan sometime ago;

WHEREAS, the Multi-Purpose Cultural Center can also serve as adequate venue for a continuing Skills Development Training Program on Livelihood projects for unemployed housewives and out of school youth, to alleviate poverty and as deterrent to drug abuse;

NOW, THEREFORE, upon motion of Hon. Romeo T. Ledesma, Chairman, Committee on tourism, History, Cultural affairs and Manpower Development, and duly seconded by Hon. Remedios T. Torrato and Hon. George T. Tribunal,

RESOLVED, to request Hon. Franklin M. Drilon, Senator of the Republic, to allocate Ten Million Pesos (P10,000,000.00) for the construction of Multi-Purpose Cultural Center, A Municipal Hall of Justice, An Integrated market Complex, including their respective amenities and/or facilities, in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward this resolution to Hon. Franklin M. Drilon for his kind attention to, and appropriate action on, this request.
