RESOLUTION REQUESTING FUNDING ASSISTANCE FROM THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) THROUGH THE HONORABLE CHAIRWOMAN, MA. LIVIA “HONEY GIRL” SINGSON-DE LEON FOR THE PURCHASE OF VARIOUS MEDICINES AND ESSENTIAL DRUGS IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) FOR THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, R.A. 7160, otherwise known as the Local Government Code of 1991 delegated specific functions and responsibilities to LGU’s particularly on the effective delivery of basic services at the local level;

WHEREAS, there is an urgent need to provide fund assistance to Local Government Units in order to alleviate their financial burdens in carrying out their functions and responsibilities as specified in the Code;

WHEREAS, the Municipal Government of Tigbauan has requested the assistance of the Philippine Charity Sweepstakes Office (PCSO) through the Honorable Chairwoman, Ma. Livia “Honey Girl” Singson-De Leon for funding in the amount of P100,000.00 as financial assistance to augment the medicine supplies allotted to our indigent constituents;

WHEREAS, the project aims to bring down the morbidity and mortality rate of acute and chronic illness that seriously affects the poor sector of the Municipality wherein most of these diseases can be controlled thru the provision of medicines and essential drugs where these people have very limited access

NOW, THEREFORE, on motion of Hon. Cecilia T. Garrido, Chairwoman, committee on Health and Sanitation and was duly seconded by Hon. Agaton O. Tumabotabo,

Livia “Honey Girl” Singson-De Leon for the purchase of various medicines and essential drugs in the amount of One Hundred Thousand Pesos (P100,000.00), for the Municipality of Tigbauan, Province of Iloilo
