RESOLUTION APPROVING THE PROPOSED ESTABLISHMENT OF SLAUGHTERHOUSE LOCATED AT BARANGAY 3, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Government of Tigbauan is in need of a new, clean and adequate slaughterhouse to provide sanitary and good quality of meat to the consumers and to generate additional income for the municipality;

WHEREAS, the said slaughterhouse shall be constructed in the government owned Lot Nos. 5364 and 5365 located at Brgy. 3, Tigbauan, Iloilo;

WHEREAS, the establishment of this new slaughterhouse will likewise provide employment opportunities to the populace;

WHEREAS, there is a one million (P1,000,000.00) Grant Funds from the Department of Agriculture, that will finance said project of the municipality;

WHEREAS, on September 21, 2001, the Sangguniang Bayan of Tigbauan, Iloilo in a session assembled passed Resolution No. 2001-091 authorizing the Municipal Mayor of Tigbauan, Iloilo to enter into a Memorandum of Agreement (MOA) with the Regional Director of the Department of Agriculture (DA), Region VI, Iloilo City and to sign pertinent documents relative thereto for the availment of said one million (P1M) grant funds and this amount is intended for the proposed establishment of the slaughterhouse located at Brgy. 3, municipality of Tigbauan, Province of Iloilo;

NOW, THEREFORE, on motion of Hon. Alfonsito Estoce, Chairman Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Agaton Tumabotabo,

RESOLVED, to approve the proposed establishment of slaughterhouse located at Brgy. 3, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward the copies of this Resolution to DA Regional Office, National Meat Inspection Commission and to all concerned for their information and/or appropriate action.
