RESOLUTION REQUESTING POLICE SENIOR INSPECTOR ANTONIO BERSAMIN, CHIEF OF POLICE, TIGBAUAN PNP TO STRICTLY IMPLEMENT THE TRAFFIC RULES AND REGULATION ORDINANCES, THIS MUNICIPALITY

WHEREAS, based on the studies and observations by the Sangguniang Bayan of Tigbauan, Iloilo several weeks regarding the flow of traffic in this municipality, it was found out that there are rampant violations on traffic rules and regulations;

WHEREAS, because of these violations, the respect involving police matters has redounded to the loss of credibility and condemnation of inefficient performance of duties and responsibilities;

WHEREAS, it was also observed that the pedestrians especially the students are not properly guided in crossing on our pedestrian lanes or of our streets;

WHEREAS, if the traffic is not on its proper order, the protection of lives and properties of the general public especially the students and our children shall also be neglected;

WHEREAS, it is incumbent upon the Tigbauan Chief of Police to strictly implement the traffic rules and regulation ordinances of this municipality;

NOW, THEREFORE, on motion of Hon. Agagton Tumabotabo, Vice Chairman, Committee on Transportation, Communication and Energy and duly seconded by Hon. Alfonsito Estoce,
