## Resolution No. 2001-120

RESOLUTION REQUIRING CONCERNED HOUSEHOLDS AND ESTABLISHMENTS TO REMOVE CONSTRUCTIONS, OBSTACLES, OBJECTS AND ANY FORM OF NUISANCE ALONG THE ROADS, ALLEYS AND PUBLIC PLACES PARTICULARLY THOSE FRONTING THEIR HOUSES AND ESTABLISHMENTS IN SUPPORT OF PROVINCE OF ILOILO GOVERNOR NIEL TUPAS CAMPAIGN FOR CLEAN ANDD GREEN PROGRAM

WHEREAS, the Governor of the Province of Iloilo has called on the Local government units to support the Clean and Green Program of the Province of Iloilo;

WHEREAS, one of the objects of the Clean and Green Program is a cleanup drive to remove constructions, obstructions, objects and any form of nuisance along the roads, alleys and public places particularly those in front of households and establishments;
