Resolution No. 2001-121

RESOLUTION DISMISSING THE CASE FILED BY MR. VIRGILIO RAMOS AGAINST PUNONG BARANGAY JACINTO TOME ET AL OF BARANGAY BAGACAY, TIGBAUAN, ILOILO

WHEREAS, on October 3, 2001 at 10:00 A.M. the complainant, Mr. Ramos appeared to the Committee of The Whole for the preliminary hearing held at the conference room, Tigbauan, Iloilo of the complaint filed against Punong Barangay Jacinto Tome, Kagawad Yolando Tuvillara, Kagawad Perpetua Torreverde, Kagawad Simproso Tial and Kagawad Honorato Torrequite;

WHEREAS, on October 3, 2001 at 10:00 A.M., the abovenamed respondents, also appeared to said preliminary hearing held at Conference Room, Tigbauan Municipal Building, Tigbauan, Iloilo to answer allegations filed against them;

WHEREAS, the complaint filed against said respondents are the following:

1. Harassment
2. Obstruction of Justice
3. Violation of Human Rights

4. Graft and Corruption
5. Perjury
6. Moral Damages
7. Negligence

WHEREAS, during the preliminary hearing, Mr. Ramos said that he filed said complaint against his will; that he believes that this complaint resulted due to some miscommunications; that at first he does not want to resort to the filing of this case because he wanted to maintain a good relationship with the people in the said barangay; that although he felt aggrieved to the decision of his lawyer to file this case (when he conferred about his problems on his poultry farm), he has no alternative but to push through with the filing of this case to protect also his investment;

WHEREAS, Mr. Ramos further stated that he is willing to withdraw the case and maintain again a good relationship with the barangay officials as well as to extend help what is due to the barangay;

WHEREAS, Punong Brgy. Tome said that he and Mr. Ramos had been in good terms ever since and he is very much willing to extend the necessary assistance to Mr. Ramos to the best of his ability;

WHEREAS, Kagawad Tuvillara said, the said problem was actually settled already in the barangay level last September 1, 2001 and he assured to help Mr. Ramos in case the same problem in the future may arise;

WHEREAS, Kagawad Perpetua Torreverde said that she's so glad that they have come up to this amicable settlement; that they wanted Mr. Ramos to know that they also care and love Mr. Ramos in their barangay;

WHEREAS, Kagawad Simproso Tial said that as a public servant he is only doing his duties and responsibilities; that he is also willing to help Mr. Ramos;

WHEREAS, Kagawad Torrequite said that everything is now in order because the problem is now resolved and he is also willing to help Mr. Ramos sand also to help one another in case there will be problems in their barangay,

NOW, THEREFORE, on motion of Hon. Romeo Ledesma, Chairman, Committee on Good Government, Public Ethics, Accountability and Civil Service and duly seconded by Hon. Alfonsito Estoce, Hon. Agaton Tumbaotabo and Hon. George Trribunal,

RESOLVED, to dismiss the case filed by Mr. V. Ramos against Punong Barangay Jacinto Tome et al of Brgy. Bagacay, Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to the complainant, Mr. & Mrs. Ramos, the respondents, Brgy. Capt. Jacinto Tome et al and to all concerned for their information.
