RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM SENATOR JOHN OSMENA, SENATOR OF THE REPUBLIC OF THE PHILIPPINES IN THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P400,000.00) FOR THE CONSTRUCTION OF TIGBAUAN PNP BUILDING THRU VICE GOVERNOR ROBERTO "OBET" ARMADA

WHEREAS, Tigbauan is a fast growing municipality with 52 Barangays having a total population of 57,368 as of the latest census, and with 25, 357 registered voters as of May 14, 2001;

WHEREAS, because of a rapidly expanding population and presently congested municipal building where our PNP station is being housed;

WHEREAS, the PNP Station where they are located is not adequate to serve the needs of the people of Tigbauan;

WHEREAS, the PNP command is in dire need of a new and commodious building;

WHEREAS, due to financial constraints the Municipal Government of Tigbauan, cannot put up a new building;

NOW, THEREFORE, on motion of Hon. Alfonsito Estoce, Chairman, SB Committee on Internal rules, Ordinances and resolutions and duly seconded by Hon. Romeo T. Ledesma,

RESOLVED, to request financial assistance from Senator John Osmena, Senator of the Republic of the Philippines in the amount of four Hundred Thousand Pesos (P400,000.00) for the construction of Tigbauan PNP building thru Vice Governor Roberto “Obet” Armada,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. John Osmena, Senator of the Republic of the Philippines, for his information and appropriate favorable action, to Hon. Roberto “Obet” Armada, vice Governor, Province of Iloilo and to Hon. Mayor Myrna M. Torres for their information and favorable indorsement.
