RESOLUTION WELCOMING HON. ORVILLO “NONONG” TANGENTE AS THE NEW EX-OFFICIO MEMBER OF OUR SANGGUNIANG BAYAN, HAVING BEEN DULY ELECTED PRESIDENT, LIGA NG MGA BARANGAYS, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Liga ng mga Barangays has the primary purpose of determining the representation of the barangays in the Sangguniang Bayan, and as a vehicle “. . .for ventilating, articulating, and crystallizing issues (and problems) affecting government administration, and securing, through proper and legal means, solutions thereto.” (*Section 491, R.A. 7160 – Local Government Code of 1991*);

WHEREAS, the Liga ng mga Barangays in the Municipality of Tigbauan has the principal aim of promoting the development of our barangays, and the general welfare of their inhabitants. “All other powers and duties vested upon the Liga are ancillary to this principal aim and purpose.” (*Comments on Section 491 in relations to Section 16, R.A. 7160 – KEY TO NATIONAL DEVELOPMENT*);

WHEREAS, the duly elected President of the Lig ng mga Barangays at the Municipal level shall automatically serve as Ex-Officio Member of the Sangguniang Bayan (Section 494, in relation to Section 446, R.A, 7160 – Local Government Code of 1991);

WHEREAS, Hon. Orvillo “Nonong” Tangente, twice elected Punong Barangay of Brgy. 4 – Poblacion, was elected President, Liga ng mga Barangays of the Municipality of Tigbauan on September 16, 2002, garnering an overwhelming forty nine (49) votes out of fifty two (52) barangays;

WHEREAS, his impressive qualifications and experiences will certainly enhance further the capability of our Sangguniang Bayan, for a progressive and peaceful Tigbauan;

NOW, THEREFORE, on motion of HON. ROMEO T. LEDESMA, Chairman, SB Committee on Good Government, Public Ethics, Accountability and Civil Service and duly seconded unanimously, BE IT

RESOLVED, as we hereby Resolved, to welcome Hon. Orvillo “Nonong” Tangente as the New Ex-Officio Member of our Sangguniang Bayan, Municipality of Tigbauan, Province of Iloilo,
