RESOLUTION ENDORSING THE RENEWAL OF QUARRY PERMIT TO THE OFFICE OF THE PROVINCIAL GOVERNOR, PENRO, DENR REGION VI AND THE BUREAU OF MINES AND GEOSCIENCES FOR COMMERCIAL SAND AND GRAVEL AND FOR THE ENVIRONMENTAL COMPLIANCE CERTIFICATE (ECC) OF FELICETAS TRENTADO

WHEREAS, Sibalom River within the territorial jurisdiction of the Municipality of Tigbauan, Iloilo has been a good source for sand and gravel materials supplying both commercial and non commercial infrastructure development in the City and Province of Iloilo;

WHEREAS, Article 100 of the Local Government Code of 1991 empowers the Local Sangguniang Bayan to pass and endorse application permit for commercial sand and gravel at the Sibalom River and for the efficient protection and management of its natural resources;

WHEREAS, the allowance of the quarry extraction at the Sibalom River will enhance the economic condition and livelihood of the people living in the community as well as the barangay, municipality and the Province of Iloilo;

WHEREAS, this resolution supersedes Resolution No. 2002-070;
