RESOLUTION REALIGNING THE AMOUNT OF ONE HUNDRED TWENTY FIVE THOUSAND NINE HUNDRED SEVENTY FIVE PESOS AND THIRTY FOUR CENTS (P125,975.34) FOR THE PAYMENT OF THE TERMINAL LEAVE PAY OF HON. RAMONITA ALCALA, EX-LIGA NG MGA BARANGAY PRESIDENT AND DIFFERENCES FROM THE TERMINAL PAY OF CORAZON T. TUTESORA, CLERK III, VIOLETA T. TOLOSA REVENUE COLLECTION CLERK I AND AGAPITO TINASAS, UTILITY WORKER II DUE TO THE REVISED COMPUTATION OF THE TERMINAL LEAVE PAY FOR THE YEAR 2002

WHEREAS, the payment of the terminal pay of retiring employees, or officer whose term has expired, is of paramount consideration over and above the monetary obligations of the municipality as per guidelines from the Department of Budget and Management;

WHEREAS, as certified by the Municipal Accountant and Acting Municipal Treasurer, the total supplemental appropriation amounting to One Hundred Twenty Five Thousand Nine Hundred Seventy Five Pesos and thirty Four Cents (P125,975.34) be realigned for payment of the benefits of the employees and enumerated herein chargeable against the salary savings of the President of the Sangguniang kabataan Municipal Federation Plantilla from January 1 to July 31, 2002;
