RESOLUTION INVITING THE CABLE STAR CABLE TV COMPANY TO EXTEND/PUT UP THEIR CABLE TV SYSTEM SERVICES IN THE MUNICIPALITY OF TIGBAUAN, ILOILO, AND TO PLACE ANY OTHER INFORMATION TECHNOLOGY AND SYSTEMS ALLOWED UNDER OUR LAWS

WHEREAS, the Cable Star, a Cable TV System Company, legally organized under our laws was noted to have excellent services, having provided its customers and patrons with more television channels and good, entertaining, and very informative television programs and services;

WHEREAS, the cable Star TV Company has been serving the City of Iloilo and various nearby Municipality's in the Province of Iloilo;

WHEREAS, their Cable TV services is now serving the Municipality of Oton, Iloilo and their lines has reached the municipal boundary at Barangay Cabanbanan, Oton, Iloilo and is ready to extend their services, if warranted to the Municipality of Tigbauan, Iloilo;

WHEREAS, as noted, the Municipality of Tigbauan is also being covered by the Octagon Cable TV System. However, only a very few households avail of their Cable TV due to very poor services and few channels are being provided;

WHEREAS, by allowing the Cable TV Company to extend their Cable TV services to the municipality, our people maybe able to enjoy, quality and more entertaining TV channels, and better cable services;

WHEREAS, by allowing the Cable Star TV Company to serve our community, this may result to better informed viewing public, updated global and international news and information and a better Tigbauanon;

NOW, THEREFORE, on motion of Hon. Rexfel G. Trivilegio, and duly seconded by Hon. Romeo T. Ledesma & Hon. Cecilia T. Garrido,

RESOLVED, as it is hereby resolve, to invite the Cable Star Cable TV Company to extend/put up their Cable TV System Services in the Municipality of Tigbauan, Iloilo, and to place any other information technology and systems allowed under our laws,

RESOLVED FURTHER, to furnish copies of this resolution to the Cable Star TV Company, Diversion Road, Iloilo City, the National Telecommunications Commission (NTC), Tabuc Suba, Jaro, Iloilo City and other government agencies and instrumentalities for their information and guidance.
