RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 09-02-125 LOT NO. 4084 OF OSCAR TRAYA ET. AL OF POBLACION, TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-09-02-125 and its supporting documents of Oscar Traya Et. Al, was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on August 28, 2002 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents was forwarded to the Office of the Sangguniang Bayan last September 9, 2002 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application. Lot No. 4084, OCT/TCT #T-14251 with four sub-lots has a total land area of 2,765 square meters more or less;

WHEREAS, the purpose/intent of this application is to sell;

WHEREAS, the condition of said approval shall be the following:

- a. In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;

- c. Any misrepresentation of material falsehood on your part shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLRB.

NOW THEREFORE, on motion of Hon. Rexfel G. Trivilegio and duly seconded by Hon. Cecilia T. Garrido,

RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the simple Subdivision Application No. 09-02-125, Lot No. 4084 of Oscar Traya Et. Al of Poblacion, Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Honorable Mayor Myrna M. Torres for her information and appropriate action, Land Management Sector, DENR Region VI, Iloilo City for their verification and approval of its field survey returns, and to the HLURB Iloilo City to support said application for the registration of the subdivision.
