RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 09-02-126 LOT NO. 3009 OF AGAPITO TINASAS ET. AL OF PARARA NORTE, TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-09-02-126 and its supporting documents of Agapito Tinastas Et. Al, was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on September 10, 2002 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents was forwarded to the Office of the Sangguniang Bayan last September 18, 2002 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application. Lot No. 3009, OCT/TCT #F-29054 with two sub-lots has a total land area of 1,474 square meters more or less;

WHEREAS, the purpose/intent of this application is to sell;

WHEREAS, the condition of said approval shall be the following:

- c. Any misrepresentation of material falsehood on your part shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLRB.

RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the simple Subdivision Application No. 09-02-126, Lot No. 3009 of Agapito Tinasas Et. Al of Parara Norte, Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Honorable Mayor Myrna M.
