RESOLUTION RESPECTFULLY REQUESTING HONORABLE PANFILO LACSON, SENATOR OF THE REPUBLIC TO ALLOCATE TWO HUNDRED THOUSAND (P200,000.00) PESOS FOR THE MAINTENANCE AND GRAVELLING OF FARM-TO-MARKET ROAD IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is composed of fifty two (52) barangays , nine of which are situated in the Poblacion and the rest are scattered around the Poblacion and spread up to the boundaries of the Municipality of Oton, San Miguel, Tubungan, Leon and Guimbal;

WHEREAS, as of December 2001 the Municipality of Tigbauan has a population of 53,297 inhabitants (actual survey) and has an appropriate land area of 8,889 has, belonging to land capacity classes B & X which means it has a slope characteristic ranging generally from zero percent to eight percent;

WHEREAS, with the standard just mentioned above the municipality land area is suitable for intensive agriculture, pasture development & productive forest development;

WHEREAS, the Municipality of Tigbauan has two (2) basic industries, namely: Agriculture and fishing;

WHEREAS, the component barangays of the municipality are accessible by cars, jeepneys, tricycles and tri-sicads because of the feeder road network connecting the barangay to the provincial road;

WHEREAS, the lack of maintenance and gravelling of the farm-to-market road especially in far-flung barangay is causing its inhabitants especially the farmers so much difficulty in transporting their farm inputs and products to and from the barangay particularly during rainy season;

WHEREAS, the maintenance and gravelling of farm-to-market road is a plus factor in the development of the barangay in general and well-being of the residents in particular;

WHEREAS, the municipal government and the affected barangays lack the financial capability for the maintenance and gravelling of the farm-to-market road necessary for the effective and efficient delivery of service to the populace;

NOW, THEREFORE, on Motion of Hon. Fernando M. Valencia and duly seconded by Hon. Cecilia Garrido, Hon. George Tribunal and Hon. Romeo Ledesma,

RESOLVED, to respectfully request Hon. Senator Panfilo Lacson to allocate the amount of Two Hundred Thousand (P200,000.00) Pesos for the maintenance and gravelling of farm-to-market road in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Panfilo Lacson and to Hon. Municipal Mayor Myrna M. Torres for their information and/or appropriate action.
