RESOLUTION APPEALING TO HON. MANUEL B. VILLAR JR., SENATOR OF THE REPUBLIC, TO ALLOCATE THREE HUNDRED THOUSAND (P300,000.00) PESOS FROM HIS AVAILABLE FUNDS FOR THE REPAIR, IMPROVEMENT AND MAINTENANCE OF THE CIRCUMFERENTIAL ROAD LINKING BRGYS. TARO, ALUPIDIAN AND JAMOG, ALL IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, there is dire need to urgently repair, improve, and maintain the circumferential road linking at least three (3) barangays, namely Barangay Taro, Brgy. Alupidian and Brgy. Jamog, all in the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, this is a Farm-To-Market Road that is used as the sole exit of various farm products, such as vegetables, bananas, root crops, mangoes, corn and palay, including cottage industry products, from the above-stated farming communities, up to the market in the Poblacion, or even direct to the city markets of Molo, La Paz, and Jaro, Iloilo City;

WHEREAS, the repair, improvement and maintenance of this Farm-To-Market Road will certainly contribute to the total development of Tigbauan, considering the volume of this municipality's inland farm production;

WHEREAS, Tigbauan has a booming population, and our registered voters may increase tremendously to thirty thousand (30,000) or more;

WHEREAS, the repair and improvement of this Farm-To-Market Road is of paramount importance because it is the main artery by which farm products are transported and sold in the market; and if marketing basically determines production, then this road becomes essential in sustaining the lifeblood of the people in these barangays;

NOW, THEREFORE, on Motion of HON. GEORGE T. TRIBUNAL and duly seconded by Hon. Romeo Ledesma and Hon. Fernando Valencia, BE IT

RESOLVED, as we hereby resolve, to Appeal To Hon. Manuel B. Villar Jr., Senator Of The Republic, To Allocate Three Hundred Thousand (P300,000.00) Pesos From His Available Funds For The Repair, Improvement And Maintenance Of The Circumferential Road Linking Brgys. Taro, Alupidian And Jamog, All In The Municipality Of Tigbauan, Province Of Iloilo

RESOLVED FURTHER, that copies of this Resolution be furnished Hon. Senator Manuel B. Villar, Jr. Philippine Senate, Manila; Mayor Myrna M. Torres and the Liga ng mga Barangay, Tigbauan, Iloilo for their information and appropriate action.
