RESOLUTION COMMENDING THREE (3) PNP MEMBERS OF OUR TIGBAUAN PNP STATION, NAMELY: SPO1 BERNARDO UMayAO, SPO1 REMEGIO MOLEÑO, AND SPO1 ROMEO TANUTAN FOR THEIR SPLENDID EFFORTS IN INTERCEPTING TWO ALLEGED “AKYAT BAHAY” GANG MEMBERS SUSPECIOUSLY LOITERING NEAR ILECO 1, BARANGAY NAMOCON, TIGBAUAN, ILOILO AT THE UNHOLY HOUR OF 2:20 O’CLOCK IN THE MORNING OF MARCH 10, 2003

WHEREAS, while conducting their regular police patrol, the above-mentioned PNP Members of the Tigbauan Police Station intercepted the following suspicious – looking characters loitering in the vicinity of ILECO I, namely:

1. JONARD ASTURIAS Y. BAUTISTA, 22 years old, single, Driver and resident of Zone 1, Calumpang, Molo, Iloilo City; and
2. ALIAS “MAKOY” ANDRADE Y ZALDIVAR, 20 years old, single, Driver, and a resident of Sto. Niño Norte, Arevalo, Iloilo City;

WHEREAS, with their service vehicle (Honda Dream Tricycle, color red, Plate No. PS – 6322, with no Registration Certificate), parked beside the National Highway fronting ILECO I, plus their suspicious actuations in that unholy hour away from their respective residence in Iloilo City, they are conclusively presumed to be alleged members of the notorious so called “Akyat Bahay” gangs;

WHEREAS, Tigbauan PNP records will show that houses clustered around ILECO I, have been previously robbed and victimized by “Akyat Bahay” gangs operating from Iloilo City;

WHEREAS, when intercepted by our Tigbauan PNP and asked to produce their IDs and/or any documents to identify themselves, they could not produce any, nor could they justify their suspicious presence in the vicinity of ILECO I, Barangay Namocon, at that precise unholy hour in the morning of March 10, 2003;

WHEREAS, it is the adopted policy of our SB Committee on Good Government, Public Ethics, Accountability, and Civil Service, to give credit where credit is due among our LGU employees with exceptional performance, especially among our PNP who conscientiously do their duties;

NOW, THEREFORE, upon Motion of HON. ROMEO LEDESMA, Chairman, SB Committee on Good Government, Public Ethics, Accountability and Civil Service, and duly seconded by Hon. Orvillo Tangente and Hon. Alfonsito Estoce, BE IT

RESOLVED, as we hereby resolve, to commend three (3) PNP Members of our PNP Tigbauan Station, namely SPOI BERNARDO UMayAO, SPOI REMEGIO MOLEÑO, and SPOI ROMEO TANUTAN, for their splendid efforts in intercepting two (2) alleged “Akyat Bahay” gang members suspiciously loitering near ILECO I, Barangay Namocon, Tigbauan, Iloilo at the unholy hour of 2:20 o’clock in the morning of March 10, 2003,
