RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 02-03-128, LOT NO. 457 OF GEGORIO TICMAN ET, AL., TEJERO ST., TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-02-03-128 and its supporting documents of Gregorio Ticman Et. Al., was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on February 7, 2003 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last February 13, 2003 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 457, TCT #T-12790 with four (4) sub-lots has a total land area of 4,741 square meters more or less;

WHEREAS, the purpose of this application is to sell;

WHEREAS, the condition of said approval shall be the following:

- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.
