RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 02-03-130, LOT NO. 3451 OF HRS. OF NICOLAS TUVILLA ET, AL., POBLACION, TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-02-03-130 and its supporting documents of Hrs. of Nicolas Tuvilla Et. Al., was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on March 21, 2003 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last March 21, 2003 also by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 3451, TCT # F-39443 with four (4) sub-lots has a total land area of 33,144 square meters more or less;

WHEREAS, the purpose of this application is to sell;

WHEREAS, the condition of said approval shall be the following:

- c.) Any misrepresentation or material falsehood on your part shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

NOW, THEREFORE, on Motion of Hon. Rexfel G. Trivilegio and duly seconded by Hon. Jose Donel Trasporto and Hon. Alfonsito Estoce,
