RESOLUTION AUTHORIZING THE MAYOR OF THE MUNICIPALITY OF TIGBAUAN, ILOILO, HON. MYRNA M. TORRES TO SIGN IN THE MEMORANDUM OF AGREEMENT FOR THE CREATION OF THE SIBALOM-BAGUINGIN WATERSHED MANAGEMENT BOARD

WHEREAS, Republic Act No. 7160 known as the Local Government Code of 1991 directs and authorizes local government units to establish, maintain, preserve, protect and conserve communal forests and watersheds;

WHEREAS, Provincial Government of Iloilo created the Iloilo Watershed Management Council as per Provincial Ordinance No. 2000-041 to realize the mandate stipulated in R.A. 7160 known as the Local Government Code of 1991;

WHEREAS, Iloilo Watershed Management Council serves as an over-all coordinating body of all watersheds in the Province of Iloilo and shall oversee the implementation of an Integrated Watershed Management Strategy in the Province under an equitable, sustainable, multiple-use, demand-driven and participatory development;

WHEREAS, Iloilo Watershed Management Council is mandated to assist in the creation and establishment of Local Watershed Management Boards in identified watershed planning units in the Province of Iloilo;

WHEREAS, the Municipal Government to strengthen the provision stipulated in R.A. 7160 and in Provincial Ordinance No. 2000-041 specifically for the proper management and protection of the environment and the watersheds is mandated to establish a local watershed management council;

WHEREAS, realization of the creation of the Sibalom-Baguingin Watershed Management Board will be only materialized through the signing of the Local Chief Executive concerned in the Memorandum of Agreement;

WHEREAS, the Sangguniang Bayan Members of the Municipality of Tigbauan, Iloilo by virtue of the powers vested on us by law, do hereby authorize, Hon. Mayor Myrna M. Torres, Tigbauan,

Iloilo, to sign in the Memorandum of Agreement for the creation of the Sibalom-Baguwingin Watershed Management Board;

NOW, THEREFORE, on motion of Honorable Rexfel G. Trivilegio, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation which was duly seconded by Hon. Romeo Ledesma and Hon. Remedios Torrato,

RESOLVED, to authorize the Mayor of the Municipality of Tigbauan, Iloilo Hon. Myrna M. Torres, To Sign In The Memorandum Of Agreement For The Creation Of The Sibalom-Baguwingin Watershed Management Board,

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Mayor Myrna M. Torres, Tigbauan, Iloilo and all concerned for their information and/or appropriate action.
