RESOLUTION AUTHORIZING HON. MYRNA M. TORRES, MUNICIPAL MAYOR, TIGBAUAN, ILOILO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ILOILO PROVINCIAL GOVERNMENT FOR THE PURCHASE OF TWO (2) UNITS COMPUTER FOR TIGBAUAN ELEMENTARY SCHOOL (TES), TIGBAUAN, ILOILO

WHEREAS, Section 444 (1) (vi) of Local Government Code of 1991 states that the Municipal Mayor, as Chief Executive of the Municipal Government, shall upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all books, contracts and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Municipality of Tigbauan is a recipient of financial assistance for the purchase of two (2) units computer for Tigbauan Elementary School (TES), Tigbauan, Iloilo in the amount of P100,000.00 from Hon. Governor Niel d. Tupas in line with the program and/or projects of the Iloilo Provincial Board;

WHEREAS, for the efficient implementation by the Iloilo Provincial Board of the School Programs, and/or projects in the different municipalities, an agreement must be entered by and between the Provincial Government and the Recipient municipalities;

WHEREAS, the parties shall have the following agreements:

LGU-TIGBAUAN as recipient of financial assistance from the Provincial School Board (PSB) and Tigbauan Elementary School (TES) as beneficiary will undertake the construction, repair and maintenance of TES, Tigbauan, Iloilo in the amount of P100,000.00;

The programs/project in the Agreement must be implemented within the period of one year from the date of release/transfer of fund;

LGU-TIGBAUAN undertakes to make a regular official report on the implementation thereof, and the Iloilo Provincial Governor reserves the right to inspect through his authorized representative the accomplishment of the programs/projects;

All expenditures thereof shall be accounted for properly in accordance with the existing provisions of applicable laws;

WHEREAS, the parties to the Agreement hereby agree to full performance of the Agreement contained herein;

NOW, THEREFORE, on motion of Hon. Agaton O. Tumabotabo, Chairman, Committee on Education and was duly seconded by Hon. Romeo Ledesma and Hon. Fernando Valencia,

RESOLVED, to authorize Hon. Myrna M. Torres, Municipal Mayor to enter into a memorandum of agreement with the Iloilo Provincial Government for the purchase of two (2) units computer for Tigbauan elementary School (TES), Tigbauan, Iloilo,
