Resolution No. 2003-054

RESOLUTION URGING THE HONORABLE MEMBERS OF BOTH HOUSE OF CONGRESS TO PASS HOUSE BILL 4110 OR THE REPRODUCTIVE HEALTH CARE ACT

WHEREAS, Article II, Section 15 of the Philippine Constitution provides that “the state shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Article XV, Section 3 (1) of the same Constitution also provides that “the state shall defend the right of spouses to found a family in accordance with their religious convictions and the demands to responsible parenthood;

WHEREAS, the Philippines is a signatory to International Agreements, among them the Convention on Economic, Social And Cultural Rights (ESCR) which identified the following interrelated and essential elements that comprise the right to health depending upon the conditions prevailing on availability, accessibility, acceptability and quality;

WHEREAS, the World Health Organization (WHO) has defined Reproductive Health as “the state of complete physical, mental and social well-being and not merely the absence of disease or infirmity, in all matters relating to the reproductive system and to its functions and processes. This implies that people are able to have a satisfying and safe, sex life and that they have the capability to reproduce and the freedom to decide if, when and how often to do so. Implicit in this last condition are the right of men and women to be informed and to have access to safe, effective, affordable and acceptable methods of family planning of their choice, as well as other methods of their choice for regulation of fertility and the right of access to appropriate health-care services that will enable women to go safely through pregnancy and childbirth and provide individuals and couples with the best chance of having a healthy infant. Reproductive health has the following ten elements:

1. Family Planning
2. Maternal and Child Health and Nutrition
3. Prevention and Management of Abortion and its Complications (PMAC)
4. Prevention and Management of Reproductive Tract Infections
5. Education and Counseling on Sexuality and Sexual Health
6. Breast and Reproductive Tract Cancers and Other Gynecological Conditions
7. Men’s Reproductive Health

- 8. Adolescent and Youth Health
- 9. Violence Against Woman and Children
- 10. Prevention and Treatment of Infertility and Sexual Dysfunction

WHEREAS, there is now pending before the Philippine Congress, House Bill 4110 or the Reproductive Health Care Act seeking to establish an Integrated National Policy and Program on Reproductive Health that recognizes men’s and women’s reproductive rights, gender equality and ensure universal access to reproductive health services, information and education,

NOW, THEREFORE, on motion of Hon. Cecilia T. Garrido, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Romeo Ledesma and Hon. Remedios Torrato,

RESOLVED, to urge the Honorable Members of Both House of Congress to Pass House Bill 4110 or the Reproductive Health Care Act,

RESOLVED FURTHER, to forward copies of this Resolution to the Family Planning, Organization of the Philippines, Inc. (FPOP), Iloilo Provincial Chapter, Iloilo Mission Hospital Compound, Jaro, Iloilo City thru Luis J. Jaspe, Jr. and Mona Lisa S. Diones, Advocacy Assistance and Chapter Program Manager, respectively, to Honorable Mayor Myrna M. Torres and to all concerned for their information, guidance and/or appropriate action.
