RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 05-03-133, LOT NO. 3288 OF FLORA T. MONDIDO OF BARANGAY PARARA NORTE, TIGBAUAN, ILOILO

WHEREAS, the simple subdivision Application No. SSA-05-03-133 and its supporting documents of flora T. Mondido was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on May 28, 2003 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last May 28, 2003 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 3288, TCT #F- 39483 with three (3) sub-lots has a total land area of 3,245 square meters more or less;

WHEREAS, the purpose of this application is to sell;

WHEREAS, the condition of said approval shall be the following:

- a. In the vent of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b. Comply with all the corrections as indicated on the plans;
- c. Any misrepresentation or material falsehood on your part shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLURB;
- f. The applicant shall install drainage system on his property.
