RESOLUTION REQUESTING THE SIRILAN SURVEYING OFFICE TO RESURVEY ALL LOTS BELONGING TO THE JURISDICTION OF BARANGAY BINALIUAN MAYOR AS PER ATTACHED BARANGAY RESOLUTION NO. 04, S. 2003

WHEREAS, the Barangay Council of Binaliuan Mayor, Tigbauan, Iloilo passed Barangay Resolution No. 04, Series of 2003 requesting for a Sangguniang Bayan endorsement for the re-survey of all lands belonging to the jurisdiction of said Barangay;

WHEREAS, barangay Binaliuan Mayor, Tigbauan, Iloilo was surveyed by the Sirilan Surveying Office in 1973, allegedly however, there was failure in the survey and the final results were not submitted to the Bureau of Lands, thus making the owners of all real properties short of titles to their properties;

WHEREAS, due to the failure of Sirilan Surveying Office, all real properties in the area were not titled as prescribed under the law, and cannot be properly transferred or distributed among heirs;

NOW, THEREFORE, on motion of Hon. Rexfel Trivilegio, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and was duly seconded by Hon. Alfonsito E. Estoce,

RESOLVED, to request the Sirilan Surveying Office to Re-Survey all lots belonging to the jurisdiction of Barangay Binaliuan Mayor as per attached Barangay Resolution No. 04, S. 2003,

RESOLVED FURTHER, to furnish copies of this Resolution to the Hon. Mayor Myrna M. Torres, the Punong Barangay, Barangay Binaliuan Mayor, the Provincial Governor, Province of Iloilo, the Bureau of Lands Region VI, Sirilan Surveying Office, Iloilo City and other government agencies and instrumentalities.
