RESOLUTION ADVISING MAYOR MYRNA MONTEALEGRE TORRES TO POLITELY DECLINE AND/OR REFUSE THE PROBABLE APPOINTMENT AND ASSIGNMENT OF DR. EMILIO FAMATID, PHD, AS DEP-ED DISTRICT SUPERVISOR HERE IN THE DISTRICT OF TIGBAUAN, FOR THE GOOD OF THE SERVICE

WHEREAS, Dr. Emilio Famatid, PhD, was forced to file for retirement in March 2003 as District supervisor of Dep-Ed District of Tubungan, allegedly because he had a deep misunderstanding with the Mayor of that Municipality;

WHEREAS, the above-stated Dr. Famatid allegedly had also a serious misunderstanding with the Principal II of Tubungan Central School (Mrs. Angelina Sansaet), including their School Principal and Head-Teachers in the Dep-Ed District of Tubungan, thereby causing problems thereat for lack of rapport with local school and LGU officials;

WHEREAS, before his application for retirement could take effect, he got himself reinstated from some personal reasons, and now he is seeking appointment and assignment as District Supervisor here in the District of Tigbauan;

WHEREAS, we have qualified candidates for the position of District Supervisor, who are residents of Tigbauan, and who also deserve to be appointed by reason of their academic training, supervisory experience, and superb intellectual equipment;

WHEREAS, if Dr. Famatid is planning to have himself reinstated, he must be accommodated in Tubungan District - - the original place of this appointment;

WHEREAS, he is not a resident of Tigbauan, and therefore he has no built-in sympathy and rapport with the Tigbaueños;

WHEREAS, for the good of the service, we shall uphold the dignity of Tigbauan District by refusing to be a dumping ground of REJECTS from other Dep-Ed Districts;

NOW, THEREFORE, on Motion of HON. ROMEO T. LEDESMA, Chairman, S.B. Committee on Good Government, Public Ethics, Accountability & Civil Service, and duly seconded by Hon. Agaton Tumabotabo & Hon. Remedios Torrato, BE IT

RESOLVED, as we hereby resolve, to advise Mayor Myrna Montealegre-Torres to politely decline and/or refuse the probable appointment and assignment of Dr. Emilio Famatid, PhD, as Dep-Ed District Supervisor here in the District of Tigbauan for the good of the Service,

RESOLVED FURTHER, to express our satisfaction and support for the splendid efforts and cooperation of MRS. TERESITA S. TOLOSA, Principal II, Designated Incharge of the District since April 30, 2002 vice Mrs. Lorenza G. Gentolea who passed away,

RESOLVED FINALLY, to furnish copies of this resolution to the Office of Hon. Mayor Myrna M. Torres, to Dr. Raymundo A. Lapating, Iloilo school Division Superintendent, to Mrs. Teresita S. Tolosa, Principal II & In-charge District of Tigbauan, and to any school official concerned, for their information and appropriate action.
