RESOLUTION STRONGLY ENDORSING THE RESOLUTION NO. 06. S, 2003 OF THE LIGA NGA MGA BARANGAY, REQUESTING HONORABLE OSCAR “OCA” GARIN, CONGRESSMAN, FIRST CONGRESSIONAL, DISTRICT OF ILOILO TO FACILITATE TO THE DEPARTMENT OF PUBLIC WORKS, AND HIGHWAYS (DPWH) THE CONVERSION OF TIGBAUAN-PARARA, JAMOG-LEON-TUBUNGAN PROVINCIAL ROAD INTO A SECONDARY NATIONAL ROAD, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Tigbauan-Parara-Jamog-Leon-tubungan Provincial Road was established in the year 1950’s;

WHEREAS, since that year up to the present, the said Provincial Road linking to Leon and Tubungan has helped improve the economic life of the people;

WHEREAS, during the time when Sibalom Bridge in Tigbauan was damaged by flashfloods, the said Tigbauan Parara-Jamog-Leon-Tubungan Road was used as a detour road for other vehicles plying Iloilo-Guimbal Miag-ao-Igbaras-Tubungan-San Joaquin and the Municipalities of Antique and vice versa;

WHEREAS, because of the construction of Iloilo International Airport, the said road is also considered as a junction or linkage road from Cabatuan where the International Airport is located going to the southern part of Iloilo and for Antique Province;

WHEREAS, we believe that if converted to national road, there will be a chance that the said road will be improved for concretement and/or asphalted;

NOW, THEREFORE, on motion of Hon. Orvillo T. Tangente, President Liga ng mga Barangay and duly seconded by Hon. Romeo T. Ledesma and Hon. Remedios T. Torrato,

BE IT RESOLVED, to request Honorable Oscar “Oca” Garin, Congressman, First Congressional District of Iloilo to facilitate to the Department of Public Works and Highways (DPWH) the conversion of Tigbauan-Parara-Jamog-Leon-Tubungan Provincial Road into a Secondary National Road, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to congressman Oscar “Oca” Garin, First Congressional District of Iloilo, to the Department of Public Works & Highways (DPWH) for their information and immediate favorable action and to the Honorable Sangguniang Bayan of Leon, and Honorable Sangguniang Bayan of Tubungan, Iloilo for their support and strong endorsement.
