WHEREAS, the barangay Captains of the different barangays, this Municipality comprising the Tigbauan-Parara-Jamog-Leon-Tubungan Road do hereby URGENTLY APPEAL TO GOVERNOR NIEL D. TUPAS, GOVERNOR, PROVINCE OF ILOILO for the emergency rapir and maintenance by surfacing of the said road because of its bad condition which is already dangerous to the li8ves and properties of the riding public;

WHEREAS, because of its bad condition, the drivers of the Public utility Vehicles (PUV's), Jeepneys and Tricycles, this Municipality plying said route are planning to boycott if said road is not immediately repaired;
