RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 10-03-139, LOT NO. 6468 OF CIRIACO TUMADIANGET-AL OF BARANGAY CORDOVA NORTE, TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-10-03-139 and its supporting documents of Ciriaco Tumadiang Et-Al was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on October 23, 2003 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last October 23, 2003 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 6468, TCT #F-40580 with two (2) sub-lots has a total land area of 5,208 square meters more or less;

WHEREAS, the condition of said approval shall be the following:

- This approval does not exempt the proponent from pertinent requirements of other government agencies;

- e. This approval does not exempt the proponent from securing registration and license to sell from HLURB;
- f. The applicant shall install drainage system on his property.
