RESOLUTION AMENDING RESOLUTION NO. 2003-098, GRANTING ADDITIONAL BENEFIT/EXTRA CASH GIFTS TO THE MUNICIPAL OFFICIALS AND REGULAR EMPLOYEES IN THE AMOUNT OF TEN THOUSAND PESOS (P10,000.00) EACH INSTEAD OF FIVE THOUSAND PESOS (P5,000.00), PREVIOUSLY APPROVED, AS AUGMENTATION FOR THE P5,000.00 AUTHORIZED UNDER DBM BUDGET CIRCULAR NO. 2003-7 DATED DECEMBER 5, 2003 CHARGEABLE AGAINST THE SAVINGS FROM THE PERSONAL SERVICES OF THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, PROVINCE OF ILOILO

Presented for consideration by the August Body is the letter of the Municipal Mayor, Hon. Myrna M. Torres dated December 23, 2003 requesting the Honorable August Body for a special Session to be held on December 29, 2003 for the urgent passing of a resolution for augmentation of additional benefits/extra cash gifts in addition to the P5,000.00 for the Municipal Officials and Regular Employees to be taken from the savings of personal services as per letter dated December 15, 2003 of Executive Secretary Alberto G. Romulo for Honorable Emilia T. Boncodin, Secretary,. Department of Budget and Management, Manila;

WHEREAS, the grant of additional benefit/extra cash gifts to the municipal officials and regular employees was approved by the Office of the President of the Republic of the Philippines as per aforestated letter of Executive Secretary Alberto Romulo to DBM Secretary Emilia T. Boncodin subject to pertinent budgetary, accounting & auditing rules and regulations & under the following conditions:

- 1.) the additional benefit being requested is within the personal services limitation under Section 325 (a) of R.A. 7160; and

2.) The personal services limitation shall be computed in accordance with Local Budget Circular No. 75, dated July 12, 2002

WHEREAS, the total amount of One Million One Hundred Ninety Four Thousand Pesos (P1,194,000.00) as reflected in the Certified Statement of Savings as of December 31, 2003 duly signed by the Municipal Accountant and the OIC-Municipal Treasurer is available for disbursement for the said benefits;

WHEREAS, this resolution supersedes Resolution No. 2003-098 passed during the Special Session of this August Body on December 19, 2003;

NOW, THEREFORE, on motion of Hon. Rexfel g. Trivilegio, Chairman, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and was duly seconded by Hon. George Tribunal,

RESOLVED, to Amend Resolution No. 2003-098, Granting Additional Benefit/Extra Cash Gifts To The Municipal Officials And Regular Employees In The Amount Of Ten Thousand Pesos (P10,000.00) Each Instead Of Five Thousand Pesos (P5,000.00), Previously Approved, As Augmentation For The P5,000.00 Authorized Under DBM Budget Circular No. 2003-7 Dated December 5, 2003 Chargeable Against The Savings From The Personal Services Of The Different Offices Of The Local Government Unit Of Tigbauan, Province Of Iloilo
