Resolution No. 2004-001

RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 02-03-140, LOT
NO. 3700 OF NORAVIC TUPIDO ET. AL. OF BARANGAY BUYUAN, TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-02-03-140 and its supporting
documents of Noravic Tupido Et. Al, was submitted to the Office of the Evaluation Officer,
Tigbauan, Iloilo on December 01, 2003 for evaluation

WHEREAS, after the evaluation, the said Subdivision Application and its supporting
documents were forwarded to the Office of the Sangguniang Bayan last December 01, 2003 by
the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 3700, TCT NO. TD-0550 with four (4) sub-lots
has a total land area of 845 square meters more or less;

WHEREAS, the purpose of this application is to subdivide among heirs/co-owners;

WHEREAS, the condition of said approval shall be the following:

- a. In the event of partial submission of subdivision plans, the same shall be
considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220
shall be observed;
- b. Comply with all the corrections as indicated on the plans;
- c. Any misrepresentation or material falsehood on your part shall be a sufficient cause
for the cancellation of this approval and/or legal action;

- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLURB.

NOW, THEREFORE, on motion of Hon. Agaton O. Tumabotabo and duly seconded by Hon. Orvillo Tangente and Hon. Romeo Ledesma,

RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the Simple Subdivision Application No. 02-03-140, Lot No. 3700 of Noravic Tupido Et. Al., of Barangay Buyu-an, Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Honorable Mayor Myrna M. Torres for her information and appropriate action, Land Management Sector, DENR Region VI, Iloilo City for their verification and approval of its field survey returns, and to the HLURB Iloilo City to support said application for the registration of the subdivision.
