RESOLUTION AUTHORIZING HON. REXFEL G. TRIVILEGIO AND HON. JOSE DONEL TRASPORTO TO TEMPORARILY REPLACE HON. ROMEO T. LEDESMA AND HON. REMEDIOS TORRATO IN THE COMMITTEE ON GOOD GOVERNMENT, PUBLIC ETHICS, ACCOUNTABILITY AND CIVIL SERVICE, WHO WILL INHIBIT THEMSELVES, VOLUNTARILY, AS A MATTER OF “DELICADEZA”, FROM THE FACT-FINDING INVESTIGATION REGARDING THE COMPLAINT FILED AGAINST HON. ORVILLO TANGENTE BY MR. MICHAEL RYN TORRATO, DUE TO THE VERY CLOSE RELATIONSHIPS OF HON. LEDESMA AND HON. TORRATO TO THE RESPONDENT AND COMPLAINANT, RESPECTIVELY

WHEREAS, in the forthcoming fact-finding investigation to be conducted by the Committee on Good Government, Public Ethics, Accountability & Civil Service, arising from the complaint filed by Mr. Michael Ryan Torrato against Hon. Orvillo Tangente, Ex-Officio Member of this Sanggunian, it has already been perceived (and pre-judged) by the public that the respondent and complainant are closely related to Hon. Romeo T. Ledesma and Hon. Remedios T. Torrato respectively, of the aforesaid SB Committee;

WHEREAS, to preclude any perceived bias from the public mind as already alleged, Hon. Ledesma and Hon. Torrato have decided voluntarily, as a matter of “delicadeza”, to inhibit themselves from the above-stated fact-finding investigation, and/or any consequent action arising therefrom, in order to preserve and protect the integrity of both this committee, and the whole Sanggunian as a collegial body;

WHEREAS, it has been suggested that Hon. Rexfel Trivilegio and Hon. Jose Donel Trasporto be requested and authorized to act temporarily for and in behalf of Hon. Ledesma and Hon. Torrato;

NOW, THEREFORE, on motion of Hon. Alfonsito Estoce, Chairman, Committee on Rules, Ordinances and Resolution and was duly seconded by Hon. Fernando M. Valencia, Be It

RESOLVED, as we hereby resolved, to authorize Hon. Rexfel Trivilegio and Hon. Jose Donel Trasporto to temporarily replace Hon. Romeo T. Ledesma and Hon. Remedios Torrato in the Committee on Good Government, Public Ethics, Accountability and Civil Service, who will inhibit themselves, voluntarily, as a matter of “delicadeza”, from the fact-finding investigation regarding the complaint filed against Hon. Orvillo Tangente by Mr. Michael Ryan Torrato, due to the very close relationships of Hon. Ledesma and Hon. Torrato to the respondent and complainant, respectively,

RESOLVED FURTHER, to furnish copies of this Resolution to all Members of this Hon. Sangguniang Bayan, and to the complainant.
