RESOLUTION RECOMMENDING APPROVAL OF THE SUPPLEMENTL APPROPRIATION FROM THE LOCAL GOVERNMENT SERVICES EQUALIZATION FUND IN THE AMOUNT OF SIX HUNDRED NINETY THREE THOUSAND NINE HUNDRED EIGHTY FIVE (P693,985.00) PESOS

WHEREAS, the Local Government Unit of Tigbauan has received an amount from the Department of Budget and Management for the municipality's share of the Local Government Services Equalization Fund (LGSEF) in the amount of P693,985.00;

WHEREAS, it was resolved by the Sangguniang Bayan that the funds shall be budgeted as per recommendation of the Municipal Mayor for the following: for the eight (8) members of the Sangguniang Bayan and two (2) Ex-Officio members namely the SKMF and the ABC President shall received an equivalent amount of Ten Thousand (P10,000.00) Pesos each which shall be allocated for their prioritized projects. The amount of Thirty Thousand (P30,000.00) Pesos shall be allocated for the Municipal Vice Mayor and the remaining amount shall be allocated for the computerization of the three departments of the LGU and the balance shall be intended for the Barangay assistance to be given to all fifty two (52) barangays of the municipality;

NOW, THEREFORE, on motion of Hon. Rexfel G. Trivilegio, Chairman, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded by Hon. Alfonsito E. Estoce and Hon. Orville Tangente,

RESOLVED, to Recommend Approval Of The Supplemental Appropriation From The Local Government Services Equalization Fund In The Amount Of Six Hundred Ninety Three Thousand Nine Hundred Eighty Five Pesos (P693,985.00),

RESOLVED FURTHER, to furnish copies of this resolution to the Office of the Municipal Mayor, Tigbauan, Iloilo, Municipal Budget Officer, OIC, Office of the Municipal Treasurer, Municipal Accountant and other concerned government agencies and instrumentalities.
