Resolution No. 2004-016

RESOLUTION URGING HON. MAYOR MYRNA M. TORRES TO STRICTLY ENFORCED THE OFFICIAL USE OF THE TIGBAUAN MMT VEHICLES, AND OUR OTHER GOVERNMENT CARS, WHICH ARE FOR OFFICIAL USE ONLY, FOR THE SAKE OF DELICADEZA AND TRANSPARENCY, INORDER TO UPHOLD THE GOOD IMAGE OF OUR LOCAL GOVERNMENT UNIT (LGU)

WHEREAS, reports and raw information have reached our Sangguniang Bayan that an MMT vehicle/van was allegedly seen often and regularly at night in Barangays Parara Sur and Parara Norte;

WHEREAS, an MMT vehicle had been allegedly seen parked at a discreet distance from a nightspot-disco house in Iloilo City;

WHEREAS, the alleged nocturnal peregrinations of this MMT vehicle were apparently without the knowledge or consent of our Mayor;

WHEREAS, except upon request, when these MMT vehicles are needed by school authorities to transport Tigbauan contestants (dancers/singers/participants) in DepEd competitions, and for other official functions where this Local Government Unit (LGU) is officially represented, these vehicles must be FOR OFFICIAL USE ONLY by appointed or elected functionaries of this LGU, in the exercise of their official duties;

WHEREAS , circumstances permitting, civilian candidate of the Mayor and her husband must have that DELICADEZA to inhibit themselves from using these vehicles, or hitching a ride therein, because private uses of these vehicles, especially on political sorties and for other political purposes, are illegal per se and therefore condemnable;

WHEREAS, the Drivers of these MMT vehicles, and all concerned, must be enjoined to observe official use, and the accomplishment of trip tickets, etc.;

WHEREAS, the evident purpose of this Resolution is for transparency and to protect the good image of our LGU against the pervasive notion that allegedly the Mayor could no longer discharge effectively the duties of her Office due to her recent illness, by her apparent lack of knowledge of the illegal use of these vehicles;

NOW, THEREFORE, on Motion of Hon. Romeo T. Ledesma, Chairman, SB Committee on Good Government, Public Ethics, Accountability and Civil Service, and duly seconded by Hon. Remedios T. Torrato, Be It

RESOLVED, as we hereby resolve, to Urge Hon. Mayor Myrna M. Torres To Strictly Enforce The Official Use Of The Tigbauan MMT Vehicles, And Our Other Government Cars, Which Are For Official Use Only, For The Sake Of Delicadeza And Transparency, Inroder To Uphold The Good Image Of Our Local Government Unit (LGU)

RESOLVED FURTHER, to furnish copies of this resolution to all department heads, and all concerned for their information, dissemination and appropriate action.
