RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO.04-04-142, LOT
NO. 199 OF SPS. MIKE & NOLIE MAGNAWA ET-AL OF TAÑALES-TEJERO STREETS,
TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-04-04-142 and its supporting
documents of Sps. Mike & Nolie Magnawa Et. Al was submitted to the Office of the Evaluation
Officer, Tigbauan, Iloilo on April 12, 2004 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its
supporting documents were forwarded to the Office of the Sangguniang Bayan last April 13,
2004 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 199, OCT #-15887 with two (2) sub-lots has a
total land area of 424 square meters more or less;

WHEREAS, the purpose of this application is to subdivide among heirs/co-owners and
consolidation;

WHEREAS, the condition of said approval shall be the following:

- a. In the event of partial submission of subdivision plans, the same shall be considered
in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be
observed;
- b. Comply with all the corrections as indicated on the plans;
- c. Any misrepresentation or material falsehood on your part shall be a sufficient cause
for the cancellation of this approval and/or legal action;

- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLRB,
- f. The applicant shall install drainage system on his property.

NOW THEREFORE, on motion of Hon. Alfonsito Estoce and duly seconded by Hon. Jose Donel Trasporto and Hon. Romeo Ledesma,

RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the Simple Subdivision Application No. 04-04-142, Lot No. 199 of Sps. Mike & Nolie Magnawa Et. Al of Tañales-Tejero Streets, Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Honorable Mayor Myrna M. Torres for her information and appropriate action, Land Management Sector, DENR, Region VI, Iloilo City for their verification and approval of its field survey returns, and to the HLURB Iloilo City to support and application for the registration of the subdivision.
