RESOLUTION AUTHORIZING HON. MYRNA M. TORRES, MUNICIPAL MAYOR, TIGBAUAN, ILOILO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL DIARY AUTHORITY (NDA), THRU ITS ADMINISTRATOR, MS. SALVACION M. BULATAO, FOR THE MILK FEEDING PROGRAM IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the government recognizes malnutrition as one of the social problems besetting our country today and it is hereby committed to work for the upliftment of the nutritional status of its people;

WHEREAS, a Milk Feeding Program is an instrument in alleviating the malnutrition problem, particularly in improving the nutritional status of the vulnerable age group the children and the nursing or pregnant mothers;

WHEREAS, the Department of Agriculture, through the National Dairy Authority, implements its dairy programs along two-pronged objectives pursuing a Milk Feeding Program for children to improve nutrition and at the same time providing livelihood to the dairy farmers;

WHEREAS, the LGU is embarking on a nutrition project that will eradicate the malnutrition problem among children in this municipality;

WHEREAS, for and in consideration of the foregoing premises, their mutual consent hereinafter set forth, the parties hereto agree to undertake the program under the following terms and conditions:

ARTICLE I
THE PROGRAM

1. The Program shall be entitled "The Milk Feeding Program" in the Municipality of Tigbauan, Province of Iloilo which aims to provide 200ml fresh milk to re-identified malnourished pre-school children on a continuing and regular basis for a total of 120 days.
2. The NDA, through the assistance of the LGU, has pre-identified the beneficiaries on the basis of the following criteria:
 - a. high incidence of malnourished children in the area;
 - b. proximity of the feeding site to the source of fresh milk;
 - c. availability of cooling facilities for the milk;
 - d. accessibility of the feeding site to transport facilities; and
 - e. not a recipient of any feeding program
3. The NDA and the LGU shall sponsor the Milk Feeding Program under 50.50 counterpart parting schemes.

ARTICLE II
COUNTERPART SHARING ARRANGEMENTS

The NDA and the LGU mutually agree to provide a 50.50 counterpart share each in the provision of fresh milk which will be used for the program based on counterpart sharing.

ARTICLE III
TERMS OF PAYMENT

1. On the part of the NDA
Payment shall be made every after 15th day of the month of milk deliveries upon completion and presentation by the supplier of all supporting documents which shall include among others, a Statement of Account and the Original copies of the Delivery Receipts/Charge Invoices duly signed by the authorized representatives of the program.
2. On the part of the LGU
To facilitate the distribution of milk taking into consideration the processing of documents in the local level, the LGU shall provide a mobilization fee equal to 50% of the LGU counterpart to the supplier as 50% advance payment for milk charges at the start of the program. The initial 50% payment shall be turned-over to the Supplier during the Program Launching to highlight the affair. The remaining 50% shall be given by the LGU to the Supplier on the 60th day of the feeding in full payment for the LGU counterpart fund for the program Payment shall be made upon completion/presentation by the Supplier of Official Receipts duly signed by its authorized representative.

ARTICLE IV
OTHER TERMS

1. The Supplier agrees to replace the actual number of the leakages provided that plastic sachets claimed to have leak(s) shall be presented by the authorized representatives of the LGU.
2. The LGU shall inform the supplier at least two days in advance in case of temporary delivery/suspension due to some unavoidable circumstances and arrange for delivery schedules, if necessary. Also, the LGU shall inform immediately the NDA and the Supplier in cases of drop-outs of project beneficiaries to avoid excess deliveries of fresh milk.

3. The Supplier agrees to give a two-day notice to the NDA/LGU should the former be unable to deliver the milk to any particular feeding area(s) due to or for some unavoidable reasons/circumstance, except in cases such as barricades, landslides, or “force majeure” that may result to damage/spoilage of the product. In this case, however, the Supplier must have to explain in writing within forty-eight (48) hours whereby the veracity of such circumstance shall then be validated by the NDA/LGU through the duly authorized representatives of the program. Otherwise, the cost of product(s) involved shall not be borne by the NDA or the LGU.

NOW, THEREFORE, on MOTION of Hon. Alfonsito E. Estoce, Chairman, Committee on Rules, Ordinances and Resolutions and was duly seconded by Hon. Orvillo Tangente,

RESOLVED, to authorize Hon. Myrna M. Torres, Municipal Mayor, Tigbauan, Iloilo, to enter into a Memorandum of Agreement (MOA) with the National Dairy Authority (NDA), thru its Administrator, Ms. Salvacion M. Bulatao, BAI Compound, Visayas Avenue, Diliman, Quezon City, for the Milk Feeding Program in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Myrna M. Torres, Municipal Mayor, Tigbauan, Iloilo and to the National Dairy Authority, thru Ms. Salvacion M. Bulatao, and to all concerned for their information and/or appropriate action.
