RESOLUTION AUTHORIZING THE MUNICIPAL VICE MAYOR AND THE MUNICIPAL TREASURER TO BE THE SIGNATORIES OF CHECKS AND OTHER REQUIRED DOCUMENTS FOR WITHDRAWAL AND DISBURSEMENT OF FUNDS FOR OPERATION OF THE SANGGUNIANG BAYAN FROM THE OFFICIAL DEPOSITORY BANKS OF THE MUNICIPAL GOVERNMENT OF TIGBAUAN

WHEREAS, Section 445 (1) of the Local Government Code (RA 7160) provides that the Municipal Vice Mayor shall be the Presiding Officer of Sangguniang Bayan and sign all warrants drawn on Municipal Treasury for all expenditures for the operation of the Sangguniang Bayan;

WHEREAS, to insure a smooth plan of transactions/negotiations between the depository banks and the Office of the Sangguniang Bayan, the August Body hereby authorize the Municipal Vice Mayor and the Municipal Treasurer to be the signatories of checks and other required documents for withdrawal and disbursement of funds for operation of the Sangguniang Bayan from the official depository banks of the Municipal Government of Tigbauan;

NOW, THEREFORE, on motion of Hon. Suzette T. Alquisada, Chairman, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded by Hon. Jose Donel Trasporto and Hon. Orvillo Tangente,

RESOLVED, to Authorize The Municipal Vice Mayor And The Municipal Treasurer To Be The Signatories Of Checks And Other Required Documents For Withdrawal And Disbursement Of Funds For Operation Of The Sangguniang Bayan From The Official Depository Banks Of The Municipal Government Of Tigbauan,

RESOLVED FURTHER, to forward copies of this Resolution to Municipal Mayor, Myrna M. Torres, to the Municipal Treasurer, and to the Managers of the depository banks of the LGU-Tigbauan, Iloilo for their information and appropriate action.
