RESOLUTION STRONGLY ENDORSING THE RESOLUTON NO. 06, S. 2003 OF THE LIGA
NG MGA BARANGAY, REQUESTING HONORABLE JANET GARIN, CONGRESSWOMAN,
FIRST CONGRESSIONAL DISTRICT OF ILOILO TO FACILITATE TO THE DEPARTMENT OF
PUBLIC WORKS AND HIGHWAYS (DPWH) THE CONVERSION OF TIGBAUAN-PARARA-
JAMOG-LEON-TUBUNGAN PROVINCIAL ROAD INTO A SECONDARY NATIONAL ROAD,

WHEREAS, the said Provincial Road will greatly benefit the constituents of Barangays comprising the whole Municipality of Tigbauan, Leon and Tubungan;

WHEREAS, during the time when Sibalom Bridge in Tigbauan was damaged by flashfloods, the said Tigbauan-Parara-Jamog-Leon-Tubungan Road was used as a detour road for other vehicles plying Iloilo-Guimbal-Miagio-Igbaras-Tubungan-San Joaquin and the Municipalities of Antique and vice versa;

WHEREAS, because of the construction of Iloilo International Airport, the said road is also considered as a junction or linkage road from Cabatuan where the International Airport is located going to the southern part of Iloilo and for Antique Province;

WHEREAS, we believe that if converted to national road, there will be a chance that the said road will be improved for concretement and/or asphalted;

NOW, THEREFORE, on motion of Hon. Orvillo T. Tangente, President Liga ng mga Barangay and duly seconded by Hon. Romeo T. Ledesma, Be It

RESOLVED, to request Honorable Janet Garin Congresswoman, First Congressional District of Iloilo to facilitate to the Department of Public Works and Highways (DPWH) the conversion of Tigbauan-Parara-Jamog-Leon-Tubungan Provincial Road into a Secondary National Road, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to Congresswoman Janet Garin, First Congressional District of Iloilo, to the Department of Public works & Highways (DPWH) for their information and immediate favorable action and to the Honorable Sangguniang Bayan of Leon, and Honorable Sangguniang Bayan of Tubungan, Iloilo for their support and strong endorsement.
