RESOLUTION REVIVING THE ASSIGNMENT OF SB MEMBERS AS “SB’S-OF-THE-DAY”
DURING EVERY WORKING DAY OF THE WEEK, BY THE SANGGUNIANG BAYAN OF
TIGBAUAN, ILOILO FOR A MORE EFFECTIVE AND IMMEDIATE DELIVERY OF BASIC
SERVICES TO OUR PEOPLE

WHEREAS, within the purview of the Local Government Code of 1991 (R.A. 7160), and
concomitant to its declaration of policy and guiding principles, the Sangguniang Bayan (SB) is a
structure of Local Government that should be “. . . more responsive and accountable” to the
people whom we serve;

WHEREAS, the “SB’S-OF-THE-DAY” was institutionalized by the 1995 Sangguniang
Bayan of Tigbauan, per Resolution No. 95-029 and approved on July 31, 1995;

WHEREAS, our people from far-flung Barangays, as well as other visitors, who have
some business with this Local Government Unit (LGU) are often at a loss whom to approach for
attention and guidance;

WHEREAS, aside from attending Sessions, we have sworn an Oath to serve our people
according to the best of our humble ability and conscience, in line with our pre-election
commitment to them;

WHEREAS, the assignment of SB Members as “SB’S-OF-THE-DAY” is a multi-lateral
form of “operating mechanism” that will help in meeting “the priority needs and service
requirements” of our Municipality (Section 3 (b) R.A. 7160);

WHEREAS, at least two (2) SB Members shall be on duty as “SB’S-OF-THE-DAY” during every working day of the week, their names to be posted at the SB Session Hall by the Secretariat;

WHEREAS, the SB Members have unanimously agreed to adopt the following assignment/schedule of “SB’S-OF-THE-DAY”, which shall take effect starting the 2nd week of August, 2004;
