RESOLUTION NOMINATING MRS. LORETA ARIAS, MRS. RAQUEL TABANG AND MRS.
CRISPINA TORRETA AS HEAD OF THE OFFICE OF SENIOR CITIZEN'S AFFAIRS OF THE
MUNICIPALITY OF TIGBAUAN

WHEREAS, RA 9257 was passed as an Act granting additional benefits and privileges
to Senior Citizens, amending for the purpose RA No. 7432, otherwise known as "*an act to
maximize the contribution of Senior Citizen to nation building, grant benefits and special
privileges and for other purposes*";

WHEREAS, Section 6 of RA 9257 provides the Office of Senior Citizens Affairs (OSCA)
– there shall be established in all cities and municipalities an OSCA to be headed by a Senior
Citizen who shall be appointed by the mayor for a term of three (3) years without reappointment
from a list of three (3) nominees by the Sangguniang Panlungsod or the Sangguniang Bayan.
The head of the OSCA shall be assisted by the City Social Welfare and Development Officer or
by the municipal social welfare and development officer, in coordination with the Social Welfare
and Development Office. . .(etc.);

WHEREAS, Mrs. Loreta Arias, Mrs. Raquel Tabang and Mrs. Crispina Torreta are active
and qualified members of the Senior Citizens Association of Tigbauan;
