ILOILO FOR COMMERCIAL SAND AND GRAVEL PERMIT AND TO THE OFFICE OF THE
PROVINCIAL GOVERNOR, PENRO, DENR REGION VI AND THE BUREAU OF MINES AND
GEOSCIENCES

WHEREAS, Sibalom River within the territorial jurisdiction of the Municipality of
Tigbauan, Iloilo has been a good source for sand and gravel materials supplying both
commercial and non commercial infrastructure development in the City and Province of Iloilo;

WHEREAS, Article 100 of the Local Government Code of 1991 empowers the Local
