RESOLUTION RECOGNIZING THE GREEN BRIGADE TASK FORCE OF TIGBAUAN NATIONAL HIGH SCHOOL AS THE PIONER SCHOOL BASED ORGANIZATION CREATED BY THE SANGGUNIANG KABATAAN MUNICIPAL FEDERATION TO BE ITS PARTNER TOWARDS THE PRESERVATION, PROTECTION AND IMPROVEMENT OF THE ENVIRONMENT

WHEREAS, Article II Section 16 of the 1987 Philippine constitution states that the state shall protect and advance the right of the people to a balanced and healthful ecology in accordance with the rhythm and harmony of nature;

WHEREAS, Executive Order No. 52 mandates the creation of a Youth Environment Corps in all Katipunan ng Kabataan to be known as the Green Brigade to promote environmental awareness and action among the Filipino youth; Mandating the formulation of the National Youth Environmental Action Plan and for other purposes;

WHEREAS, in pursuit for youth participation and involvement towards nation building, the Sangguniang Kabataan Municipal Federation of Tigbauan, Iloilo agreed to create a School-based organization to be its partner in preserving, protection and improving the environment;
