RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 08-04-150, LOT NO. 337-B-2-C-1 OF JOLLY FRANCISCO TANATE, SR. OF BARANGY 8 (POBLACION), TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-08-04-150 and its supporting documents of Jolly Francisco Tanate, Sr. was submitted to the Office of the Evaluating Officer, Tigbauan, Iloilo on august 20, 2004 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last August 23, 2004 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 337-B-2-C-1, TCT No. F-202633 with three (3) lots has a total land area of 2,123 square meters more or less;

WHEREAS, the purpose of this application is to sell;

WHEREAS, the condition of said approval shall be the following:

- a. In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b. Comply with all the corrections as indicated on the plans;
- c. Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;

- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLURB;
- f. The applicant shall install drainage system on their property.

RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the Simple Subdivision Application No. 08-04-150, Lot No. 337-B-2-C-1 of Jolly Francisco Tanate, Sr. of Barangay 8 (Poblacion), Tigbauan, Iloilo,
