RESOLUTION REQUESTING THE MUNICIPAL MAYOR, HON. MYRNA M. TORRES TO RE-ORGANIZE THE SIBALOM – BAGUINGIN RIVER WATERSHED BOARD THROUGH THE PROVINCIAL GOVERNMENT

WHEREAS, the Sibalom-Baguingin River Watershed Board was organized last year in order to protect and preserve the environment;

WHEREAS, the Officers and Members of the Sibalom-Baguingin Watershed Board will be the primary persons responsible for the above-mentioned undertaking;

WHEREAS, the composition of the Board will be the Municipal Officials headed by their Local Chief Executive and representatives from all Government Institutions located within the territorial jurisdiction of Tigbauan and Leon;

WHEREAS, the years of unabated deforestation in and around the watershed areas have caused water to just cascade freely through the waterways;

WHEREAS, it is the responsibility of the Municipal Government to effectively implement rehabilitation of the watershed areas of the Sibalom-Baguingin rivers;
